Re: Amendment to the Hospital Service Accountability Agreement (HSAA) - Huron Perth Healthcare Alliance 2026/27 Hospital Funding Allocations

Ontario Health (OH) is pleased to advise that Huron Perth Healthcare Alliance will receive up to \$4,323,200 in base funding (net of new investments and adjustments), and up to \$1,619,900 in one-time funding for the 2026/27 funding year.

The funding outlined in this letter is subject to the Ministry of Health (“the ministry”) receiving the necessary appropriation from the Ontario Legislature.

Please note that this information is under embargo except for operational purposes and should not be discussed with any party other than the Ministry or Ontario Health until further notice.

In accordance with Section 22 of the *Connecting Care Act, 2019*, Ontario Health hereby gives notice that, subject to your organization's agreement, it proposes to amend the HSAA between Huron Perth Healthcare Alliance and Ontario Health with effect as of the date this letter is signed back by your organization. To the extent that there are any conflicts between the HSAA and this letter, the terms and conditions in this letter, including Appendices and Schedules, if any, will govern. All other terms and conditions in the HSAA will remain the same.

Financial records of this allocation are to be maintained for year-end evaluation and settlement in accordance with the HSAA and/or Ministry policy.

Thank you for your assistance as the ministry continues its efforts to build a modern, sustainable and integrated health care system that meets the needs of Ontario's patients.

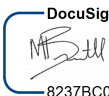

- (v) Reporting will be submitted as outlined in the HSAA unless otherwise set out in the Appendix A and attached Schedule(s), if any.
- (vi) It will provide additional information and documentation related to this funding at the request of Ontario Health and/or the Ministry.
- (vii) This funding will not increase risk to the organization's multi-year expense limits and annual balanced budget requirements.
- (viii) Funding under this Agreement is conditional upon an appropriation of moneys by the Legislature of Ontario to the Ministry and funding of the Funder by the Ministry pursuant to the Enabling Legislation.
